## 1. Prologue

## **Globalization and Migration**

From spring to summer, we come across Arctic terns on a stroll along a seaside in the Stockholm suburb. They have swallow-like tail feathers and fly gracefully yet ready for sudden diving for fishing in the water. They do not care people passing by when they rest their wings on the bank. They look like local birds fitting into the beautiful scenery of the town. In reality, Arctic terns are strangers migrated from the Antarctic all the way to Sweden. The name of the bird is misleading. They travel back and forth the Antarctic and Arctic zones in a year, flying almost 32,000 km. Arctic tern is one of the birds migrating the longest distance on the planet. It is a real global migrator. Although it is a hard life from our point of view, they should have a good reason to choose such a life style for their quality of life. On the other hand, there are also the birds such as magpie and goldfinch, which prefer to stay in the long and dark Swedish winter. Each bird takes its own life style to enjoy better quality of life in its way.

In the dawn of the mankind history, hunting and gathering were the major work for living and people also migrated around searching for their target items. Development of agriculture increased settlers and migrators represented by nomads became a minor group. However, expansion of civilization generated other kinds of migration. Northern expansion of the Roman Empire originated from the Mediterranean civilization induced the great ethnic migration initiated by Germanic tribes. "Discovery of the new continent" by Christopher Columbus led to Europeanization of North and South American continents through migration of huge number of European people. Furthermore, The Third Empire of Nazi Germany forced Jews to migrate to the United States of America or Palestine, leading to the establishment of their own country Israel. Each immigration was attempted for a better quality of life. In particular, immigration of many outstanding Jewish scientists to the United States pushed its scientific status to the top of the world. After the World War II, the United States have been keeping its scientific kingdom at the top through collecting excellent students and researchers around the world. Now, scientists have to migrate globally for studying, getting a job or attending an international conference in a foreign country.

Along with the globalization of economy, global competition of universities also becomes a hot issue. Following the United States, other advanced nations have started to solicit excellent foreign students and researchers to their universities. The advantage of the globalization is not only to get more excellent researchers, but also to generate unexpected new ideas through the communication among the people with different cultures and civilizations. The latter is not yet well recognized by Japanese universities, because it is hard for Japanese to have such experiences in an island nation. Nordic countries are also making efforts focusing on invitation of



internationally high-ranking scientists, which is the most efficient way to push up their scientific levels. The Swedish government invested SEK250,000,000 for "International Recruitment of Top Researchers" from 2013 to 2016. The rector of the Helsinki University, Prof. Jukka Kola, announced in his anniversary remark this year that one of the most important missions of the university was to recruit, recruit and recruit excellent students and researchers across the world.

Globalization in Swedish universities looks successful in graduate students, senior researchers and faculty members. Many programs in graduate school levels are taught in English. There are also programs focusing on global issues. For example, the Karolinska Institutet offers six courses in "Global Master's Programs" for foreign students from mainly emerging countries. The globalization of Swedish universities are partly associated with the immigration policy of the government. The immigrant community provides students and teaching staffs to universities. Especially in refugees, there are a certain number of highly-educated youth and intelligent people. Even newly appointed foreign staffs may feel at home in this kind of multicultural society and may be able to stay longer. Japanese universities are now trying to globalize their teaching programs, students, and teachingresearching staffs. However, successful globalization can be achieved only when the foreigners joining the university and their families feel at home not only in the university but also in the local community. Upbuilding of such a community is still a challenging issue for Japan. There is a good reason for migratory birds to form a group for the journey to a destination under a different environment.

### The 2015 Nobel Laureates and Nobel Week

In the memory of Swedish scientist Alfred Nobel, the Nobel Prize is awarded to discoveries and inventions of greatest benefit on mankind. Earlier in October, the 2015 Nobel Prize Laureates were announced, and two of the laureates were Japanese scientists. The Prize in Physiology or Medicine was awarded with one half jointly to Prof. Emeritus William C. Campbell and Prof. Emeritus Satoshi Ōmura, Kitasato University, "for their discoveries concerning a novel therapy against infections caused by roundworm parasites", and the other half to Chief Prof. Youyou Tu, China Academy of Traditional Chinese Medicine, "for her discoveries concerning a novel therapy against Malaria". The Nobel Prize in Physics was awarded jointly to Prof. Takaaki Kajita, University of Tokyo, and Prof. Emeritus Arthur B. McDonald, Queen's University, "for the discovery of neutrino oscillations, which shows that neutrinos have mass".

# December 7 – Nobel Lectures in Medicine and Reception at Karolinska Institutet

The Medicine Laureates Prof. Emeritus Satoshi Ōmura, Prof. Emeritus William C. Campbell and Chief Prof. Youyou Tu, gave lectures on their research in the full Aula Medica, Karolinska Institutet.

The lectures were followed by a reception where the invited guests could mingle and congratulate the Laureates.

#### December 8 – Nobel Lectures in Physics, Chemistry and Economics, Reception and Nobel Prize Concert

The Nobel Lectures in Physics, Chemistry and Economics were held at Aula Magna, Stockholm University. Physics Laureates Prof. Takaaki Kajita and Prof. Emeritus Arthur McDonald explained their discoveries of the neutrinos. Attending the lectures were young school children, students, researchers and others interested in science and the Nobel Prize.

Around lunch time, the Embassy of Japan organized a reception to congratulate the two Japanese Laureates. H.E. Ambassador Jun Yamazaki praised the two Laureates' achievements, and how the scientific and academic exchanges between Sweden and Japan has deepened. Following the reception, a press conference for Japanese media was held.

In the evening, the Nobel Prize Concert was held at the Stockholm Concert Hall, and this time Austrian Franz Welser-Möst conducted the Royal Stockholm Philharmonic Orchestra.

#### **December 9 – The Nobel Week Dialogue in Gothenburg**

The Nobel Week Dialogue, a symposium open to the general public, was held at the Swedish Exhibition & Congress Centre in Gothenburg. The theme of the dialogue was "The Future of Intelligence" with Nobel Laureates, world-leading scientists, experts and politicians discussing topics such as artificial intelligence.

In Stockholm, a reception organized by the Nobel Foundation and the Royal Swedish Academy of Sciences (KVA) was held at Nordiska Museet in honor of the Nobel Laureates.

#### December 10 – The Nobel Prize Award Ceremony and Banquet

Dr. Yuichiro Anzai, President of JSPS, and his spouse were invited to the Nobel Prize Award Ceremony, held at the Stockholm Concert Hall. The Nobel Laureates in Medicine, Physics, Chemistry, Literature and Economic Sciences received their diplomas and medals from the hands of H.M the King Carl XVI Gustaf of Sweden. The exclusive and festive Nobel Banquet held at Stockholm City Hall was followed, President Anzai and spouse were among the special invited guests.

### KIFEE Symposium Held in Trondheim, Norway

From September 20-23, the Kyoto International Forum for Environmental Energy (KIFEE) Symposium was held at the Norwegian University of Science and Technology (NTNU). Director Hideo Akutsu presented the activities of JSPS Stockholm Office and JSPS Programs. About 140 participated in the symposium, of whom approximately 40 participants were from Japan.

Talks were given by Norwegian and Japanese researchers, students, and officials from funding agencies, and a lively question and answer session was performed after each lecture.

Inspired by the Kyoto Protocol, the symposium was created by the universities in the Kyoto region working towards the development of a sustainable society, and it acts as an international arena for the strategic cooperation between universities.

The Bilateral Agreement on Technological Cooperation between Japan and Norway was signed in May 2004, and a long-term research cooperation that could serve as a basis for industrial cooperation was desired. Due to the good relations between NTNU and the universities in the Kyoto region, NTNU was invited to participate in the symposium.

The symposium was held for the first time in Kyoto, and has since then been consecutively held in Kyoto and Trondheim.

### The 2015 Marcus Wallenberg Prize

On September 28, Prof. Akira Isogai, the University of Tokyo, Assoc. Prof. Tsuguyuki Saito, the University of Tokyo and Dr. Yoshiharu Nishiyama, CERMAV-CNRS, were awarded the 2015 Marcus Wallenberg Prize for their development of an energy-efficient method to produce nanofibrillated cellulose. The Laureates received the prize from the hands of His Majesty the King Carl XVI Gustaf of Sweden at a ceremony in Stockholm. Prof. Isogai spoke at the ceremony, while the other two laureates Dr. Nishiyama and Assoc. Prof. Saito spoke on September 29 at the Marcus Wallenberg Prize Symposium. Dr. Nishiyama gave the lecture titled "The Cellulose Microfibril: A Universal Building Block of Plant Biomass", and Assoc. Prof. Saito's gave the lecture titled "TEMPO-mediated Oxidation as a Tool for producing Nanofibrillated Cellulose".

The prize is awarded by the Marcus Wallenberg Foundation for Promoting Scientific Research in the Forest Industry. The purpose of the prize is to recognize and encourage groundbreaking scientific achievements within the fields important to the forest and forest industries. The prize was instituted 1980 by the Stora Kopparbergs Bergslags AB (now Stora Enso) to commemorate Swedish industrialist Dr. Marcus Wallenberg, who served long-term as member and chairman of the Board of Directors.



On November 3, the first seminar of the IVA-JSPS seminar series FY2015 was held on "The future forest industry - What could Sweden learn from Japan?" at the Royal Swedish Academy of Engineering Sciences (IVA). The purpose of the IVA-JSPS seminar series is to invite Japanese researchers with excellent research achievements, and Swedish experts, to promote the scientific exchange between the two countries. The seminar was organized by IVA, the Sweden-Japan Foundation, the Embassy of Japan, and JSPS Stockholm Office.

Dr. Johan Weigelt, Secretary to the Academy and Executive Vice President, offered welcome remarks. The seminar was moderated by Prof. Mikael Lindström, KTH Royal Institute of Technology, who mentioned the theme of the seminar and the importance of forest industry to bio-economy. Prof. Lindström continued to introduce the invited speakers from Japan: Prof. Hiroyuki Yano, Research Institute for Sustainable Humanosphere (RISH), Kyoto University, and Dr. Masayoshi Watanabe, Ministry of International Trade and Industry. First, Prof. Yano gave the lecture titled "The future direction of bio-based materials inspired by nano- to micro-structures in plants". Next, Dr. Watanabe gave the lecture titled "Strategy to create advanced biomass industry".

After the lectures, a panel discussion was held with commentaries from the academic, industry and political perspectives. Representing each perspective were Prof. Lars Berglund, KTH Royal Institute of Technology, Dr. Tom Lindström, Innventia, and State Secretary Elisabeth Backteman, Ministry of Enterprise and Innovation.

## **3. Reports** (1) Activities

### Seminar and Conference on "Japanese Development Cooperation

### in the Post-2015 Era"

I visited Stockholm during September 28-October 2, 2015, at the invitation of the Japan Society for the Promotion of Science (JSPS) for two purposes: (i) to give lecture on "Japanese Development Cooperation in the Post-MDG Era" at the 60th Stockholm Seminar on Japan; and (ii) to participate in an international conference "Japanese and Nordic Perspectives of Development Cooperation in a Post-MDG Era" and make a presentation on the role of Japan in the new era of development cooperation. Both seminar/conference were COorganized by the European Institute of Japanese Studies (EIJS) and the JSPS Stockholm Office and held at the Stockholm School of Economics. In addition, the Embassy of Japan in Sweden and the Osaka University respectively co-hosted the seminar (i) and the conference (ii).

In the lecture, I explained the evolution of Japan's Official Development Assistance (ODA) policy during the past 60 years and the new Charter for Development Cooperation recently adopted by the Japanese government, and then presented my perspective of Japan's role in a post-MDG era, especially toward achieving 'quality growth' which is a high-priority issue in the new charter. In particular, I emphasized three points as follows.

First, Japan's development cooperation should give greater attention to 'cooperation' and 'competition' with Asian emerging donors. This is partly because of their rising presence in economic cooperation, but also because of shifting interests of Western donors from poverty reduction to inclusive, sustainable growth agenda. Japan should collaborate with Asian donors to disseminate the East Asian perspective of aid and development which is based on the philosophy of selfhelp efforts, while focusing on its core competence to make a distinctive contribution to the realization of 'quality growth. Second, Japan's comparative advantages should be clearly understood as being a 'mature donor', a 'knowledge partner' and a 'quality leader'. As a catch-up economy which achieved rapid economic development after Meiji and WW II, Japan has accumulated rich experiences of nation building. It should share with other countries these experiences (both successes and failures), as well as frontier challenges the country currently faces (e.g., declining birthrate and ageing). Third, Japan should strengthen 'network-based cooperation,' working with diverse partners, such as business, local governments, NGOs, universities and also mobilizing the human and institutional networks in Asia that Japan has built through the past decades of ODA.

In the Q&A session, active discussions took place over such topics as: concept and approach to promoting 'quality growth,' development cooperation to middleincome countries vs. low-income countries, modality of partnership with the private sector, and social and environmental consideration of Japan's infrastructure ODA. These are essential points and reflect the perspective of Swedish ODA which focuses on humanitarian assistance with grants (no ODA loans).

These two events were organized quite timely. Globally, the UN Summit convened at the end-September 2015 endorsed the Sustainable Development Goals (SDGs) for the 2013 development agenda. For Japan, the new Development Cooperation Charter was adopted by the government in February 2015 (by revising the 2003 ODA Charter). It should be also highlighted that Prof. Marie Soderberg, Director of EIJS at the Stockholm School of Economics was awarded the Japanese Foreign Minister's Commendations for 2015, in recognition of her longstanding contributions to intellectual partnership between Sweden and Japan. In fact, these events benefitted greatly from the knowledge and human networks that EIJS possess.

Furthermore, I had valuable opportunities to meet with the officials of the Swedish International Development Cooperation Agency (SIDA), NGOs, and researchers, to discuss the recent trend of Swedish ODA including its approach to partnership with the private sector.

I would like to express my sincere gratitude to the JSPS Stockholm Office, EIJS, and the Embassy of Japan in Sweden for giving me precious opportunities to disseminate my research and interact with Nordic researchers. Lastly, I was strongly impressed with extensive research networks on Japanese studies in Nordic countries. Thanks to Prof. Soderberg, a number of Nordic scholars specialized in Japanese ODA and diplomacy participated in the two events. I could hardly imagine the situation that Nordic and Japanese researchers discussed passionately (often, in Japanese), wide-ranging issues related to Japanese ODA--from history, public-private partnership to national security. It is important to maintain and expand such research networks on Japanese studies.

### KVA-JSPS Seminar

Hiroshi Imahori, Institute for Integrated Cell-Material Sciences (WPI-iCeMS), Kyoto University

I was invited by KVA and JSPS to give lectures in Stockholm, Uppsala, Göteborg, and Lund, Sweden on October 11-22, 2015. I would like to report on the lectureship tour with my impressions. On October 11 I flew Finnair from Kansai international airport to Stockholm international airport via Helsinki. It was cold in Sweden and the temperature of 5-10°C was the same as of December in Japan. I visited KTH on October 12-13 (host: Prof. Licheng Sun), Uppsala University on October 14-15 (host: Prof. Leif Hammerström), Chalmers University of Technology on October 16-17 (host: Prof. Bo Albinsson), and Lund University on October 18-20 (representative host: Prof. Villy Sundström), giving a lecture with a title of "Molecular Engineering for Photoinduced Charge Separation and Its Applications." Director, Dr. Hideo Akutsu, JSPS Stockholm Office, made promotion on the activities of JSPS at the universities before starting my lecture. It seemed to me this promotion was appealing to Swedish researchers who were interested in academic exchange between Sweden and Japan. I had a lot of chance to discuss with various researchers in the universities. Since I knew all the hosts very well, I felt very comfortable with my visit including a lot of discussion on collaborations relating to artificial photosynthesis and organic solar cells. The southern part of Sweden is very close to Denmark and it takes about 30 minutes from Lund to Copenhagen international airport by train. On October 21 I departed from the airport and returned to Japan on October 22, having good impressions of Sweden.

The most impressive event I experienced in Sweden was when I acted as a role of an opponent for PhD defense at KTH. The opponent is selected from leading scientists working on the related research field in foreign countries. KTH has a special lecture theater for PhD defense. It started at 10 am and at first as the opponent I had to explain the background and importance of the research as well as research achievements carried out by the candidate to audience in a popular scientific way for 20 minutes. Then, the candidate briefly presented his dissertation for 40 minutes. The candidate and I started long discussion and continued it for 40 minutes. After one-to-one fight, the other examiners also asked a lot of questions to him for 20 minutes. Finally, the chairman invited questions from the other audience. After the public PhD defense was over, the evaluation committee met to decide whether the candidate should pass the examination. Fortunately, he passed it and all the people including his colleagues, friends, and family celebrated the decision with champagne. The examiners and the candidate also had late lunch together. On the same night the candidate organized a big party to express his gratitude to people who supported him a lot and I was invited to join it. I was impressed by the transparent opponent system and unique education effect given by public PhD defense in Sweden. Although I had to prepare the presentation slides and looked into his doctoral thesis including his original publications very carefully, I really enjoyed this unforgettable event and the role as the opponent. Finally, I would like to thank all the people I met in Sweden as well as the generous support by KVA-JSPS.

### SAC Activity Seminar: "Japanese Ethics and Technology"

### at Ångström Laboratory in Uppsala University

Takashi Majima, Associate Professor, School of Business Administration, Senshu University

I visited at Uppsala University in early September. I felt chilly, but Swedish people were so kind, Swedish foods were so good. The above seminar was a fruitful one for me, Sweden days were impressive days for me.

The seminar's title was "Japanese Ethics and Technology". Electronic technology, medical technology, machine technology, information technology, and biotechnology... Any technologies have two-facedness: a positive side and a negative side. Recently, we felt that we faced many negative sides in Japan (e.g. the Accident at TEPCO's Fukushima Daiichi Nuclear Power Station). In our seminar, we discussed the manner of relationship between the technologies and us (philosophers and scientists) from the point of view of Japanese philosophy and Ethics. We had 14 presentations and panel discussion, and developed a lively discussion with many audiences.

My presentation title was "From Green to Smart: The impact of Fukushima on Green IT in Japan". I have belonged to school of business administration and have been interested in corporate organizations, because my presentation was not philosophical.

But I discussed the social construct/generative process of meanings and practices of "Green IT" from the standpoint of Actor network theory, which is a theory of origin of anthropology. Any concepts are interpreted by us in each region's context, thereby our practices are different. I discussed the indigenous practices of Green IT in Japanese context. Therefore we discussed that the meaning and practice of technology is embedded in the situation/context where is constructed by complex actor's network. And, I think that we (philosophers and scientists) must be a mediation that takes part in the context and lead our practices of the technology to the good direction for our society.

I had an exciting time by our discussion. In particular, I felt exciting, when I had an opportunity of dialogue that I rarely meet other countries' researchers and different fields' researchers. I got many fresh, surprising impressions from the other participant researchers. I found a new aspect/approach for my interest. I experienced the importance of "dialogue with different heterogeneous others", which narrative theory says the importance of it.

I met the interesting of Japanese philosophy at Sweden.

At last, I wish to express my appreciation for JSPS, JSPS office in Stockholm, SAC, and Uppsala University.





### Japanese Astronaut Kimiya Yui Back on Earth After 141 Days in Space

Japanese Astronaut Kimiya Yui of the Japan Aerospace Exploration Agency (JAXA) has returned safely on Earth after 141 days on board the International Space Station (ISS). Together with Expedition 44/45 crew members Kjell Lindgren of National Aeronautics and Space Administration (NASA) and Oleg Kononenko of the Russian Federal Space Agency (Roscosmos), Kimiya Yui landed safely on Earth in the Russian spacecraft Souyuz TMA-17M spacecraft on December 11, 2015. The crew landed in Kazakhstan on schedule at 7:12 p.m. local time and rescue teams were on site to help the crew out of the space craft. The temperature was cold and the winds were strong, but a smiling Kimiya Yui emerged and was met by a doctor for a medical check before quickly being flown to the city of Jezkazgan.

Kimiya Yui was launched into space on July 22, 2015, and together with fellow crew members he participated in Earth observations and conducted research on board the space station in physical, biological and molecular science, for the purpose of advancing the knowledge and to demonstrate new technologies. One of the new technologies demonstrated included NASA's Veggie plant growth experiment, in which Kimiya Yui and Kjell Lindgren participated. The purpose of this experiment is to grow vegetables in space by using a flat panel light bank including red, blue and green LEDs to grow plants, and it could provide a sustainable food supplement for future astronauts. After 33 days of growth, red romaine lettuce was harvested and the two astronauts could enjoy the taste of fresh lettuce together with ISS commander Scott Kelly, NASA.

The growing of vegetables in space is especially critical on long-duration exploration missions that stretch farther into the solar system, such as the journey to Mars. It could also provide recreational gardening activities for astronauts, and it could have implications for improving the growth and production here on Earth.
